This addendum document is introduced in the ABC Technology Industries' Employee Manual.

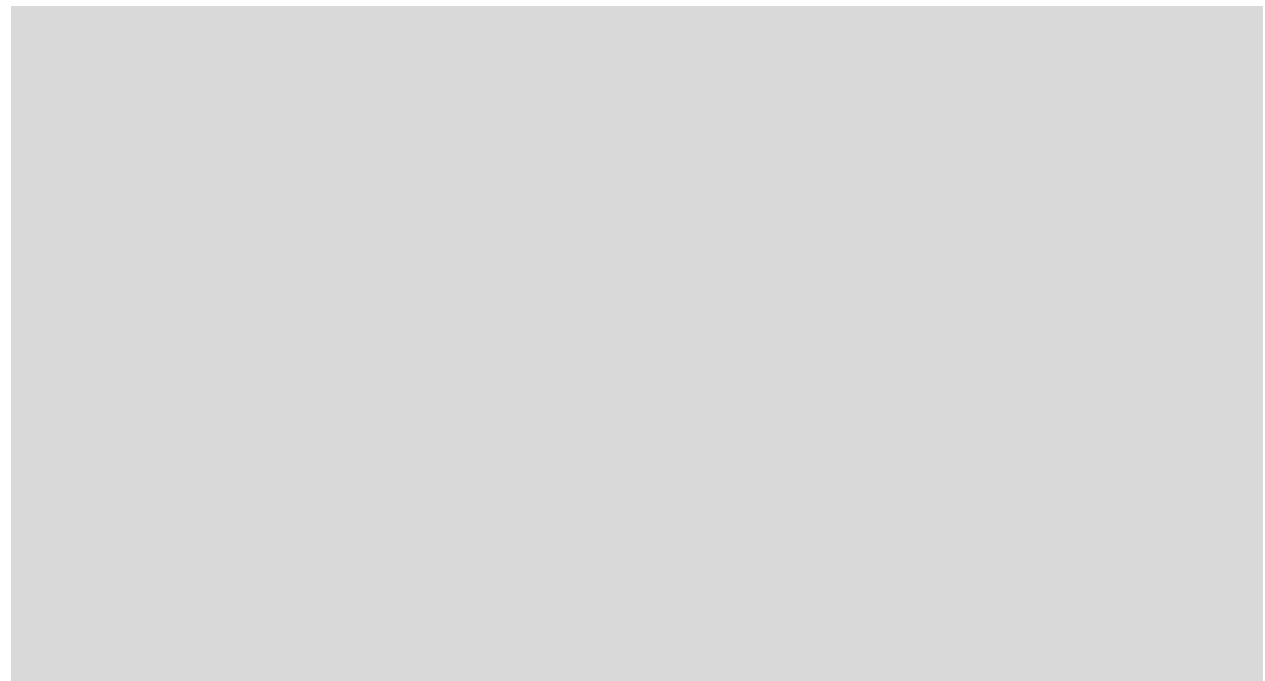
