# Why This Process is Important

When we talk to people about the possibility of working with us, we sometimes have to share company confidential or unpublished information. Some of those people may go on to work with us and sign a formal non-disclosure, but some may not. By signing a non-disclosure, candidates agree not to share what they learn about the Company with anyone else outside the Company.

To protect the Company's best interests, make sure anyone you talk to about company confidential information signs a non-disclosure before the conversation begins.

- If the person who signed the agreement is part of the recruitment process for a position, also keep a copy of the signed agreement—or the confirmation email string—in the position folder.

Sample email scripts for sending a non-disclosure agreement to a candidate ahead of a scheduled meeting.

### **Email script – with written signature**

During the course of our preliminary discussions, you may obtain knowledge and materials related to plans and information that are confidential and not public. I kindly ask that you sign off on the attached Non-Disclosure Agreement.

If you agree to and accept the terms of the attached Non-Disclosure Agreement, please:

- Review, print and sign the Agreement.
- Obtain a witness signature.
- Scan and return to me by email by insert deadline date.

#### **Email script – with email signature**

During the course of our preliminary discussions, you may obtain knowledge and materials related to plans and information that are confidential and not public. I kindly ask that you sign off on the attached Non-Disclosure Agreement.

Time is of the essence. If you agree to and accept the terms of the attached Non-Disclosure Agreement, please:

- Forward this email to me so that your reply includes my original email and the attachment by insert deadline date.
- Indicate your acceptance and agreement to the terms of the Non-Disclosure Agreement, by including the following copy with your reply:

"I accept and agree to the terms of the attached Non-Disclosure Agreement by email and in doing so, my agreement is and will remain as effective and binding as if they included my original signature."
