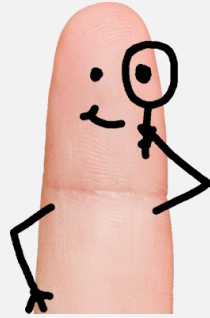

Employee Information section		
B2	Today's date	Enter today's date, in the format YYYY-MM-DD
B3	Employee name	Enter the employee's name.
B4	Title	Enter the employee's job title.
B5	Age	Enter the employee's age.
B6	Likelihood of re-employment	Select the appropriate option from the drop-down list.
B7	Hire date	Enter the employee's hire date, in the format YYYY-MM-DD
B8	Proposed date of termination	Enter the proposed termination date, in the format YYYY-MM-DD
B9	Completed, full years of service	Do not insert data into this cell. The full years of service completed value will be automatically calculated using the values entered in cells B7 and B8. Formula used: =YEARFRAC(B7,B8
B10	Termination classification	Select the appropriate option from the drop-down list.
B11	Rationale for termination	Enter a brief summary of the reason for termination.

E6	Salary	Enter the employee's current annual salary
E7	Other recurring pay	Enter the annual total for other recurring pay amounts made to the employee, if applicable.
E8	Pension contributions	Enter the annual pension contributions amount for the employee, if applicable.
E9	Bonus	Enter bonus payment amount, if applicable.
F9	Comment/Details	If you entered a value in cell E9, enter a brief description of the payment.

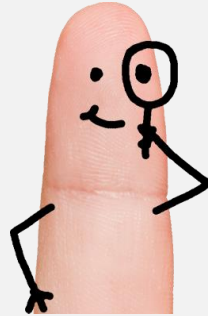

Cell	Name	How to Complete the Form
D16	# of vacation days owed > # of days	Enter the number of vacation owed.
E16	# of vacation days owed > Cost	Do not insert data into this cell. The number of vacation days cost will be automatically calculated by the formula =E11*D16 (daily wage amount multiplied by # of vacation days owed)
D17	Overtime bank > # of days	Enter the number of overtime days banked.
E17	Overtime bank > Cost	Do not insert data into this cell. The overtime cost will be automatically calculated by the formula =E11*D17 (daily wage amount multiplied by overtime bank # of days)
D18	Total days wages payable as per ESA> # of days	Do not insert data into this cell. The total number of days wages payable will be automatically calculated by summing the values in cells D14 – D17.
E18	Total days wages payable as per ESA> Cost	Do not insert data into this cell. The total cost of wages payable will be automatically calculated by summing the values in cells E14 – E17.
Supplemental Pay		
<p>Supplemental pay is any pay that the Company provides to the employee on a 'without prejudice' basis in exchange for releasing the Company from wrongful dismissal suits. It is provided in addition to pay to which the employee is legislatively entitled, based on legal requirements in the jurisdiction.</p> <p>As it relates to termination of employment, severance pay is deemed to be supplemental, as are any type of contributions the Company might make to a retirement savings plan on the employee's behalf to help offset taxes payable, etc.</p>		
B21	# of weeks of supplemental pay > Weeks per Year	Enter the number of weeks per year of supplemental pay to be provided to the employee. 4 weeks per year is common.
C21	# of weeks of supplemental pay > # of weeks payable less ESA notice	Do not insert data into this cell. The number of weeks payable will be automatically calculated using the formula =(B9*B21)-B14 (Completed, full years of service multiplied by # of weeks of supplemental pay weeks per year, minus Pay in Lieu of Notice in accordance with ESA)

E30	# of weeks of benefits continuance > Total \$ Value	Do not insert data into this cell. The benefits continuance cost will be automatically calculated using the formula =B30*D30 (# of weeks of benefits continuance multiplied by benefits cost per week)
B31	# of weeks of provincial medical coverage > Weeks	Enter the number of weeks of provincial medical coverage the Company will provide to the employee.
D31	# of weeks of provincial medical coverage > Cost per Week	Enter the weekly cost of provincial medical coverage.
E31	# of weeks of provincial medical coverage > Total \$ Value	Do not insert data into this cell. The provincial medical coverage cost will be automatically calculated using the formula =B31*D31 (# of weeks of provincial medical coverage multiplied by provincial medical coverage cost per week)
E32	Outplacement counselling > Total \$ Value	Enter the total cost of outplacement counselling, if applicable.
